

ORDINANCE NO: 577

AN ORDINANCE FOR THE CITY OF WEST COLUMBIA, TEXAS, CHANGING THAT PORTION OF 14TH STREET KNOWN AS NORTH 14TH STREET FROM THE POINT OF ITS INTERSECTION WITH BRAZOS AVENUE AND CONTINUING IN AN NORTHERLY DIRECTION TO THE POINT OF ITS INTERSECTION AND TERMINUS AT JEFFERSON STREET TO VETERANS MEMORIAL PARK DRIVE; AUTHORIZING THE CITY SECRETARY TO CERTIFY TO THE ADOPTION SUCH ORDINANCE AND TO RECORD THE SAME AMONG THE REAL PROPERTY RECORDS OF BRAZORIA COUNTY; PROVIDING FOR THE REPEAL OF ALL ORDINANCES, RESOLUTIONS, OR INFORMAL POLICIES OF THE CITY WHICH ARE IN ANY MANNER INCONSISTENT OR IN CONFLICT WITH THIS ORDINANCE; CONTAINING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WEST COLUMBIA, TEXAS:

Section One

The name of that portion of 14th Street known as North 14th Street from the point of its intersection with Brazos Avenue and continuing in an northerly direction to the point of its intersection and terminus at Jefferson Street shall be and is hereby changed to "Veterans Memorial Park Drive".

Section Two

Any rules, ordinances, police regulations, resolutions, and/or policies of the City of West Columbia, whether written, or otherwise, which are in any manner in conflict with or inconsistent with this ordinance, shall be and are hereby repealed to the extent of such conflict and/or inconsistency.

Section Three

It is hereby declared to be the intention of the City Council that the several provisions of this ordinance are severable, and if any court of competent jurisdiction enters a final order which holds that any section, sub-section, sentence, clause, phrase, or other portion of this ordinance is invalid, illegal, or otherwise

unenforceable, then any such portion shall be deemed a separate, distinct and independent provision, and any such ruling shall not affect any other provision of this ordinance which are not specifically designated as being illegal, invalid or unenforceable.


Section Four

This ordinance shall be effective and applicable immediately from and after the date of its passage and approval by the City Council of the City of West Columbia, and the publication of its caption as provided by law.

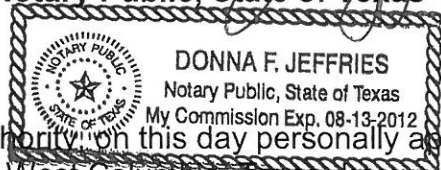
