Review the Candidate's Calendar. It lists many important dates including the deadline for filing. The City Council positions with terms expiring are: Laurie B. Kincannon - Mayor; Charley Tindol – Alderman Position 2; and Dietrich von Biedenfeld - Alderman Position 5. These are at-large positions and you may file for any position of your choosing.

Early voting will be held at various locations throughout Brazoria County. The West Columbia location is the Pct. 4 Government Office located at 121 N. 10th Street beginning April 25th and ending May 3rd. Hours for early voting are Monday, April 25th through Friday, April 29th from 8 a.m. to 5 p.m.; Saturday, April 30th from 7 a.m. to 7 p.m. and Monday, May 2nd through Tuesday, May 3rd from 7a.m. to 7 p.m. Election day voting on May 7th will be held at the same location at 7 a.m. and ending at 7 p.m. Both Early Voting and Election Day Voting allow registered voters to cast ballots at any of the county's vote centers. The ballots are processed at the County Courthouse and results are posted on the County's website at www.brazoria-county.com.

2022 CANDIDATE'S CALENDAR

January 1, 2022	First day to apply for ballot by mail.
January 19, 2022	First day for candidates to file applications for place on the ballot.
February 18, 2022	Last day for candidates to file applications for place on the ballot.
February 22, 2022	Deadline for write-in candidates to file declaration of write-in candidacy.
February 23, 2022	Drawing for Order of Names to appear on ballot by position (5:00 p.m.).
April 7, 2022	Last Day to register to vote for May 7th Election.
April 25, 2022	First day for early voting by personal appearance.
May 3, 2022	Last day for early voting by personal appearance.
May 7, 2022	ELECTION DAY
May 7, 2022	Last day to <u>receive</u> provisional ballots or ballots by mail.
May 16, 2022	City Council canvasses election.
May 16, 2022	First day candidates may be sworn in (or any time after canvass).
*July 15, 2022	Last day for candidates and office holders to file semi-annual statement of contributions and expenditures for the 2022 election.

***NOTICE: These forms are required by law to validate your campaign and failure to properly file them is a criminal misdemeanor. It is the sole responsibility of the candidate to see that the forms are filed within the appropriate time span. Failure to do so could also constitute a miss-election and result in the failure of the candidate to qualify for a position to which he/she has been elected.**
